Devenish Island (Damhinis, Island of Oxen).

Devenish Island is the most important of Lough Erne's many island churches. Devenish was active from the C6th until C16th & still later for burials.

Described c.800 AD as "multitudinous Devenish" the island hosts a group of ruined ecclesiastical buildings unique in Ireland.

These include a C12th church, 2 round towers, graveyards, a C15th abbey a high cross, cross carved stones & other architectural fragments.

There is also an enclosure, other earthworks & the site of a holy well.

- **St. Molaise,** whose death is recorded in the *Annals of Ulster* in both 563 *and* 570 A.D., founded the monastery on Devenish Island in the sixth century. He was one of the early missionaries in Fermanagh, converting the locals to the new Christian faith.
- The monastery on Devenish was to become a place of great religious and spiritual importance for the next 1000 years.
- September 12th is the feast day for St. Molaise
- As early as 650, the poet Cuimin of Conor described Devenish as a "house of hospitality for everyone in Erin."







- In the monasteries, sacred and secular manuscripts were continually copied and illuminated. The most important relic from Devenish is the <u>Soiscel Molaise</u>, or book shrine of St. Molaise, now in The National Museum of Ireland. Unfortunately, the gospel contained in the case was lost. There is a replica of the book shrine in Fermanagh County Museum.
- The monasteries were not only for adults; children were educated and fostered in monasteries. Children went to school at the age of seven.
- Monastic settlements also served as "towns" in Ireland at this time. In addition to the monastery, church, and refectory, monastic sites often had a guesthouse, school, mud huts and a dairy.

The Vikings

- Lough Erne was vulnerable to Viking attacks. The *Annals of Ulster* record that in 836, "all the churches of Loch Erne, together with Cluain Eois and Daimhinis (Devenish Island) were destroyed by the gentiles." In 923, the Annals note: "a fleet of foreigners on Loch Erne and they plundered the islands of the lake and the territories round it to and fro."
- The monastery was rebuilt after these invasions. Its churches were burned in 1157. This event led to a new building programme, this time at least partly in stone. The 'lost church', St Molaise's House and the round tower were all built in the second half of the 12th century.



Round Towers (Irish cloicthech, bell house)

- These are a feature of Irish monasteries rebuilt after the Viking invasions. The tower served as a watchtower, a belfry and as a place of refuge for people and valued treasures and books. The tower on Devenish was repaired in 1835 and 1896.
- Round towers were also symbols of prestige and reflected the wealth of the monastery.
- They were generally built in the vicinity of a church or a monastery.
- The Devenish tower is one of the finest in Ireland, reflecting the wealth of the monastery. The tower was either built soon after the 1157 fire or after 1176 when the tower was involved (unsuccessfully) in a local struggle.
- Domnall son of Amhlaoibh O Maoil Ruanaidh, King of Fir Mhanach, was burned by his own kinsmen in the round tower of Daimhinis.
- The tower is beautifully built with closely jointed stones and carefully worked details like the door, raised for security. Inside are 5 floors each with a window, above an unlit basement, and projecting stone 'hooks', which may have held bags or leather satchels for special objects. It is the only tower in Ireland to have a decorated cornice at the base of the cap. Four heads are linked by bands of pellets and spirals. Traditionally the heads show Molaise with Patrick, Columba (Colum Cille) and Brigit.
- In 1972, the foundation of a second round tower was found nearby.
- It is uncertain whether it preceded the standing tower or was a 'false start', never completed.





The History of Devenish:

Major reforms during the 12th century sought to bring Ireland into line with European practice. These changes brought about a new organisational structure; dioceses were fixed, parishes were created and new orders introduced. For the first time Cistercian monks (Assaroe, Co. Donegal) and Augustinian Canons Regular, as on Devenish were established in Ireland.

By the 11th and 12th centuries Devenish was a large, busy community. Written sources let us glimpse the scholar, Gilla Mo-Dutu O Caiside, finishing his text on the woman of Ireland on Devenish in 1147. The abbot of Drumlane in County Cavan had a house and a garden on Devenish set aside for his personal use around this time.

By the 15th and 16th centuries there were two communities living on Devenish: The Canons Regular in St. Mary's Priory and the secular canons, called Culdees in the lower church. These Culdees lived their lives separately from the community on the island.

<u>St Molaise's House</u> is a small church dating from the twelfth century.

- The present stone building was built to replace a wooden church burned in the 1157 fire. The massive walls and the decoration at its angles, show that St Molaise's House was a very special building.
- The name, St Molaise's 'House', suggests that remains of the founding saint were buried in the church. The house is a tomb or shrine. The church would have been used for individual prayer by the monks of Devenish.
- A stained glass portrait of St. Molaise was created in 1968. The portrait is inside the Church of St. Molaise (Church of Ireland) in Monea, County Fermanagh. The window is within a stone window frame which is over 450 years old, originally from St. Mary's Priory on Devenish Island.





- <u>**Teampull Mór**</u>, or the lower church, dates from the early 13th century with a beautifully moulded south window. It was later extended to include a residential wing to the north and the Maguire Chapel to the south. As the nave of St. Mary's church was relatively small, Teampull Mor was used as the parish church.
- <u>St Mary's Augustinian Priory or Abbey</u> is on the highest ground on the island and is built outside the original monastic settlement. It was begun by Augustinian Canons in the 12th century but the early abbey was destroyed by fire. Matthew O'Duggan reconstructed it in 1449. The priory was extended to include a refectory, cloister walk and other rooms, while the west doorway was rebuilt, the tower added and windows were replaced.

<u>The **Culdees**</u> (Celi de, clients or servants of God) were prominent in the Irish church in the late 8th and 9th centuries. Reacting against the old established churches, the culdees introduced a stricter regime and a series of reforms. It is possible that a group of Culdees existed at Devenish in the Early Christian period, but the word Culdee does not appear in Devenish sources until the 15th century.

Ballaun Stone.

This stone on which St Molaise crossed the sea and where pagan priests mixed blood – this two-sided ballaun was actually used for grinding food or other materials.



Stone Coffin.

This medieval coffin once formed part of 'St Molaise's Bed', a small structure on the hillside north of St Molaise's house. Sick people would seek a cure by lying in it.

Graveyards on Devenish. A Place of Burial.

Devenish was an important burial place for at least 1,300 years, from the mid 6th century to the later 19th century. The lower graveyard's boundary wall was attached to Teampull Mor. The latest tombstone is dated 1867. There are at least two stones from the Middle Ages in the upper graveyard. There is a variety of gravestones from the 18th and 19th centuries. Two stones carved with the armorial bearings of the Maguire's of Tempo are built into the chapel on the south side of Teampull Mór which was the Maguire burial vault (until about 1865).

Devenish Island has been uninhabited since 1922

The Maguire Chapel


Devenish Island's lower graveyard contains the grave of one "Thomas Maguire, who died May ye 25th, 1772. Aged 74 years", on which are recorded "Maguire Arms". McKenna (1897) defines the arms thus - "Upon waves of sea an ancient three-mast galley, sails set and flags flotant; in vase a fish, facing all to the sinster; over the shield a royal crown, surrounded by the crest; upon a wreath a stag couchant; mantling pendant from the wreath".

The inclusion of the three-masted galley has given rise to possible associations with Philip (The Maguire, 1365-1395), who in the fourteenth century is reputed to have maintained mastery over the waters of Lough Erne with a very large fleet of vessels.



Graveyard Survey

The EHS (now NIEA) commissioned a survey of the two graveyards to produce a database of the headstones and their inscriptions. This database collects the inscription catalogue, graveyard maps and headstone photographs together and makes them easily available for anyone who wants access to a complete visual record of the Devenish graveyards. The survey was conducted in May 2004.





Devenish Island Lower Graveyard Inscription Catalogue

Listed below are all of the headstone inscriptions which currently are located within the Lower Graveyard beside St. Molaise's Church. Since Bigger and Mckenna (1897) recorded the headstones, several have now disappeared or were so worn that they could not be identified.


